This past year we continued on our path of finding better ways to give a voice to our vulnerable and provide the most comprehensive way to serve their individual needs. Through our model of a free summary advice clinic, CLG provided over 5,000 people in our community legal support at our downtown and outreach clinics, with over 1,000 people receiving further service and/or representation.

In recognizing that access to justice for the most indigent extends past legal clinic support, our comprehensive inhouse programs - Family Law, Homeless Outreach, Social Benefits Advocacy, Immigration and Elder Law served over 1200 individuals. Recognizing the challenging situations of our clients, CLG is working towards a trauma informed, client-centred approach where we work with them in a safe and welcoming environment and connect them with our team of lawyers, social workers, legal assistants and community partners to address their individual needs.

The enormity of these accomplishments cannot be overstated, and because of the hard work, dedication and commitment from our leadership team, staff, Board members and volunteers, we are able to offer help, support, and hope to vulnerable individuals in our communities.

Treasurer's Report 2014 - 2015

I am pleased to report a surplus of over \$33,000 for this fiscal year. CLG finances remain strong, with a cash balance of \$309,383 and short and long-term investments (in GICs) of \$985,092.

Total revenues in the current fiscal year reached \$2.8 million, representing a \$0.2 million increase (6%) over the prior year. The increase is largely due to increased funding from the Alberta Law Foundation for our core programs by \$0.2 million. Funding from our other funders has remained relatively stable year over year. Thanks to our generous donors this year, we raised close to \$74,000 from individual donations. Operating expenses were \$2.7 million in the fiscal year, an increase of \$0.2 million, mainly due to inflationary increases in salary and wages and incremental advertising and website development costs. The figures below illustrate the sources and uses of funding of the 2014-2015 fiscal year:
